1. Introduction

1.1 Project

This server is a lightweight SMTP/POP3 java mail server. We called JPXX Mail Server (JMS, JMS not Java Mail Server). JMS is built upon standards. The mail goal of JMS was flexibility. A new feature could be added by simply creating a new class implementing the required interface. The server assumes each of these run in their own threads. At startup the mail server starts the threads then main exits. It supports two or more domains.

1.2 Download

You can download the latest version of JMS in the site at <https://sourceforge.net/projects/jpxx/>. Here you can also find further information on JMS.

1.3 System Requirements

Please ensure your computer system meets the following requirements, otherwise JMS may not work properly:

Intel/AMD based PC with Windows 2000/XP/Server 2003 operating system.

32MB (or more) of RAM

10GB (or more) hard disk is recommended

Internet connection is required.

2. Installation

To install and run this mail server, complete the following steps:

1. Install a Java JDK or JRE **version 1.6** or greater (<http://java.sun.com>).
2. Expand the distribution archive.
3. Modify the included script files for your local file system (if neccessary).

3. Command for manager

3.1 The command for mail server manager

help Manager get help from JMS.

quit Quit server. Server will be closed by force.

jms -restart Restart JMS.

jms -start Start JMS.

jms -stop Stop JMS and quit.

user -add **user** **password** **[domain]** **[mailboxsize]** Add a new user.

user -delete **user** **[domain]** Delete an exit user.

domain -add **domain** Add a new domain to Server.

domain -delete **domain** Delete a domain.

Explain:

user The user's login name.


password The user's login password.

[mailboxsize] This is not necessary for you add a user with a default size.





Package org.jpxx.mail

- * Constant: Change Constant to a final Class And modify the mail system directory.
- * Factory: The function **init()** is private now.
- * JMS: Add a new Class **JMS**. The main function in JMS instead of MailServer's main function.
- * JMSCommand: Add a newClass **JMSCommand**. This class implements some commands for JMS manager to manage the server.

Package org.jpxx.mail.Pop3

- * Pop3User: Add an new interface **Pop3User**.
- * Pop3UserMonitor: This Class implements the Pop3User's functions. In old version, the pop users who are online are stored in xml file. Now they are stored in a hash map.

Package org.jpxx.mail.User

- * UserHandler: Add some extension fiunctions
- * MailUserHandler: Complement the left functions which are not implemented.

Package org.jpxx.mail.Util

- * FileUtil: Add a newClass **FileUtil** to delete all files and directories in a special directory.

6. License Agreement

6.1. Definitions.
